## 1) Important, Time Sensitive Reminder: Catastrophic Leave Drive

The Catastrophic Leave Drive is in full swing and will go through Dec. 4 at midnight! If you would like to be a member of the Catastrophic Leave Bank, NOW is the time. Karen Kupetsky in Payroll sent a PUSD email to eligible unit members on November 5.

- One email went to those who opted in
- o If you received this email, no action is needed unless you'd like to opt out or donate more than one day. If no action is taken, you will auto-donate one day and remain eligible to apply to access the Bank per the terms of the MOU.
- Another email went to those who did not donate during the last drive o If you received this email, you may opt in if desired by donating one or more days. If you opt in during this cycle, you are also opting into auto donations for future cycles. In future cycles, you could still opt out.

The Catastrophic Leave Bank provides leave for enrollees who have exhausted all their available leave options. This leave can be used to care for yourself or for a family member impacted by a catastrophic illness when all other sick leave and paid time off have been exhausted. If you do not donate one day by December 4, you will not have another opportunity to join the Bank for three years. Temporary, Probationary, and Permanent teachers are eligible to join the Bank, but must have four days of available sick leave as of June 30, 2024. Please see the attached MOU for full terms.
